3. The Bidders who have been entrusted with S.O. /PO earlier and failed to Lift /supply the Items will not be considered for the Tender . i.e. Bid submitted by such Bidders will be Rejected.
4. Tender must be submitted in a **sealed envelope super scribed "Tender for Rate Contract for disposal of Scrap Items -2021/01 "** to General Manager, Indo German Tool Room, Vatva G.I.D.C. Ahmedabad on or before 20.01.2020 up to 2.00 PM .The tender will be opened on the same day at 3.00 pm in the presence of tender committee and present Bidders on the same day .

5. **Sealed Cover** should contain following documents :

6. Evaluation of Submitted Bids will be carried out Item wise i.e. H1 ( highest price offered ) Bidder will be decided for each item . Rate contact will be awarded to Item wise to highest Bidder for that particularly item .

If , after evaluation of Bids received , two or more bidders qualified as H1 ( i.e. offered same price) then committee may invited such bidders to remain present at IGTR , Ahmedabad on Date and Time Fixed at later stage . Such , Bidders will be asked to give their fresh offer in sealed cover, which cannot be less than previous price offered by them. This process will be repeated till only one H1 bidder is qualified .
8. **The Bidder will remove the scrap at his own risk and cost i.e, no transportation, labour or any cartage will be provided by IGTR.**  
**GST as applicable at the time of disposal will be extra .**
9. The EMD of successful Bidder (H1 ranked Bidder) will be forfeited , if successful Bidders does not take delivery in stipulated time period.
10. If , H1 Bidder refuse to lift the material , IGTR reserve the right to allot the Bid to H2 ranked Bidder subjected to H2 bidder agree to make payment equal to offered by H1 Bidder . If ,H2 ranked bidder also not agree for this , opportunity will be given to H3, H4... etc. for each item

11. Bid Security of the successful Bidder will be Returned only after completion of Rate contact duration .
