OBJECTIVES

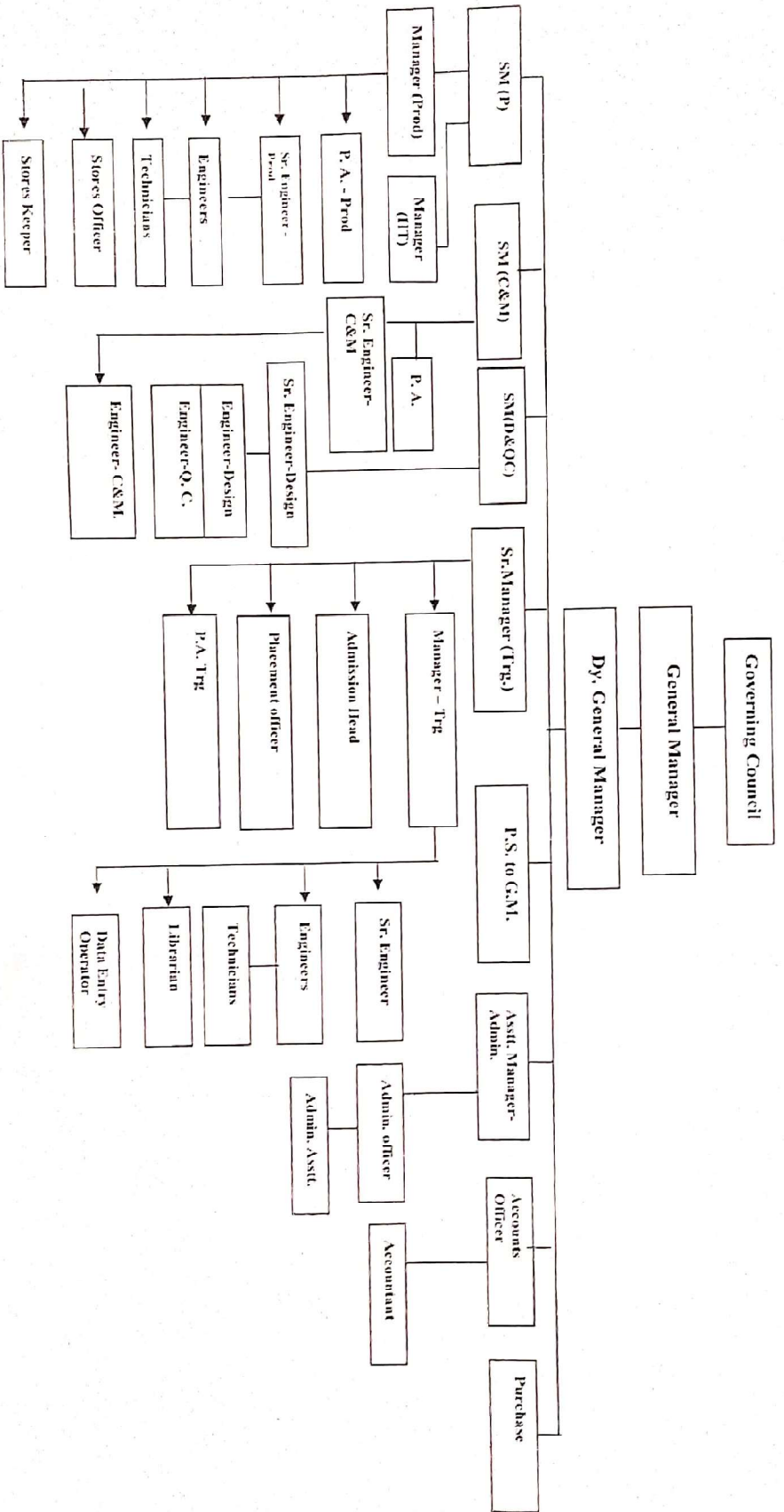
